## Lhartum Hospital Report

Happy New Year Nobles and Ladies.

As of the end of December 2022, your patient transportation fund has provided for 55 active patients to attend 128 appointments at Shriners Hospital of Children. Canada (82) Shriners Children's Twin Cities (42) and Shriners Children's Philadelphia (4). In addition, we have had 17 patients who received a telehealth visit with our medical staff from the Canadian hospital. As of the end of December we had accepted 10 new patients. Khartum's Transportation costs as of December 30, 2022 were about \$228,100.00, which includes about \$107,000 in donations toward flights West Jet and Air Canada.

Just an FYI during the Period January 2015 to December 2022 Khartum Shrine has provided for over \$1.3M toward transportation and accommodations for patients from Manitoba and NW Ontario.

At the December Board of Governors meeting held in Decem-



ber I was pleased to present a check for \$1530.99 to the hospital on behalf of Lady Shirley's fundraising project for 2022. This was a directed donation to

the Orthopedic Tower equipment. Accepting the check was Marie-Anne Desjardins Director Donor Relations, Peter Ripstein Chairman of Board Shriners Hospital for Children Canada, Dr Leslie Stewart Trustee Liaison Shriners Childrens', Imperial Sir Kenny Craven Imperial Potentate and Imperial Sir Gerry Gantt Chairman of the Board Shriners Childrens'

In 2022 the Shriners Hospital for Children Canada had 25,048 patient visits, including 5.767 new patients. There were a total of 1149 surgeries conducted (761 day surgeries and 388 hospital admission surgeries) with the average daily census (patients in the hospital at midnight) 5.32. The hospital also held 462 Telehealth visits and conducted 189 outreach clinics.

Despite loosening of restrictions in the general public, the hospital is still under slightly reduced sanitary and social distancing protocols. The surge of RSV virus across Canada has affected all pediatric centers across the country. This has seen our hospi-

tal admit post-surgical patients from The Montreal Children's Hospital to help them with their in-patient load.

For the second year in a row, the Human Resources Department in concert with the Board of Governors presented the Board of Governors Awards. This second edition was a great

success and saw an increased number of nominations in all categories. Board awards seek to recognize employees who are unsung heroes and who do make



unique and selfless contributions to the hospital.

Research grant funding increased by 10% for the 2022 calendar year, totalling \$6,146,746. This is divided into 3 sources of grant support: Shriners Hospitals for Children (\$1,510,686, an increase of 9%), government funding agencies (\$2,955,924, an increase of 7%), and pharmaceutical industry/other foundations (\$1,680,136, an increase of 17%). For each dollar of support obtained from Shriners Hospitals for Children, we leverage \$3 from external sources.

Dr. Noémi Dahan-Oliel was awarded a three year grant from Shriners Hospitals for Children for a project entitled: "EXPAND Arthrogryposis Multiplex Congenita" in the amount of \$233,124/yr. The EXPAND acronym stands for:

'EXpand the Phenotype and Advance Next generation sequencing Discovery'. This is a multisite study involving Shriners Children's sites:

Canada (Lead), Chicago, Greenville, Mexico, Northern California, Philadelphia, Portland and Shreveport.

Dr. Lisbet Haglund was awarded a three year grant from Shriners

Hospitals for Children for a project entitled: "Disease modifying therapeutics for curve progression and pain in idiopathic scoliosis" in the amount of

Screening clinics are a push for 2023. Naja already set for April. When Kem has date, Lauren Elm will be advised. Interesting stats is in 2018 had 347 patients referred through screen clinic. 2022 had 3. So this is hopefully where KEM can do their part for volume increases.

Year end financial in audit mode, can say we kept our expenses under control.

North Dakota was 4 highest state for referral in 2022.

Nobles as we move forward from our existing facility to a new facility wherever that may be and what ever that may look like, Khartum's patient transportation fund needs your continued support and commitment. You are the reason we can give these children and families the gift of hope and healing.

### L'hartum L'adies Auxiliary

2023 promises to be another busy year. We had our Installation of Officers in January and have a new President Barb Ginsberg and a new Vice President Lillian Allan.

While much of our energy is diverted at present to securing a new meeting space with the loss of Shrine House, we continue to pursue fundraising to support the children. We had great success with our Morden's Chocolate Fundraiser at Christmas and are currently considering looking to repeat that success with some different offerings- details coming soon.

We are also in discussion/planning for potentially a Card Dessert Party in the spring (if we can find a venue). This event has always been very successful and highly anticipated but we are hampered this year by loss of our usual venue at Shrine House. Any ideas anyone??

#### Lundraising Activities

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach. Your specific attention is called to the following fraternal and charitable bylaws: \$335.3 Use of Name "Shriners Hospitals For

§335.3 Use of Name "Shriners Hospitals For Children." The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the chairman of the board of trustees of the Hospitals is prohibited. §503.11 Commercial Use of Name. The use of the name "Shriners Hospitals for Children" or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the boards of directors and trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED: Fundraising for Fraternal Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations, shall engage in any fundraising activity without the express written consent of the Potentate of the temple having jurisdiction thereof.
- (b) There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
- (c) The temple Potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.11 of the fraternal and charitable bylaws and that there is no representation, expressed or implied, that would lead a reasonably prudent person to believe that the proceeds will be for the benefit of Shriners Hospitals for Children. If the Potentate is in doubt, he must receive the opinion of the Imperial Potentate who, after consultation with the Director of Temple Accounting, shall make the final determination.
- (d) The temple Potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and, additionally, as may be

required by the temple bylaws.

(e) A copy of the temple Potentate's written consent shall be sent to the Executive Vice President, Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Shriners International, shall be promptly sent to him.

#### Fundraising for Charitable Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. A request to fundraise for Shriners Hospitals for Children is now initiated through a module in WebFez. The temple recorder and/or designated staff are required to take online training to gain access to the module. See updated Charitable Fundraising - Approval and Reporting on page 46 of this publication. Permission therefor must be first obtained in writing from the temple Potentate. The temple Potentate must then obtain written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P. O. Box 31356, Tampa, FL 33631-3356. No charitable fundraising activity shall be held in the jurisdiction of another temple without the written permission of the Potentate of that temple.
- (i) A joint charitable fundraising activity with another 501(c)(3) charity may be authorized, provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
- (ii) A charitable fundraising activity conducted by a temple located outside of the U.S.A. may be authorized for other charities, provided that the chairmen of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
- (b) All Shrine temples and their units, Shrine clubs, Shrine Associations and their units and Imperial Sessions of Shriners International are prohibited from engaging telemarketing firms and direct mail firms to assist with fundraising for Shriners Hospitals for Children. No new contracts are permitted without first obtaining written permission from the chairmen of the boards of directors and trustees.
- (c) 100% of net proceeds (as defined in the Charitable Fundrais-

ing—Approval And Reporting provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of any General Order. Provided, however, if the chairmen of the boards of directors and trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution. The remaining net proceeds from charitable fundraising must be given to Shriners Hospitals for Children and may not be designated or restricted in any way other than for research at one or all of our hospitals.

- (d) The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising—Approval And Reporting provisions of any General Order.
- (e) This section shall not apply to activities exempt under §335.4(b) of the bylaws of Shriners International
- (f) Each independent corporation or entity that receives the permission of the chairmen of the boards of directors and trustees to raise moneys for Shriners Hospitals for Children, and which does not have its financial statements reviewed pursuant to §§334.6 & 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to Shriners International within 120 days of the activity.
- 3. Statement of Purpose and Disclosure:
- (a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted material, regarding the use of the proceeds.

- "Proceeds are for the benefit of Shriners Hospitals for Children."
- (b) Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on all solicitation material, including tickets, programs, documents and electronically transmitted material, that "payments are not deductible as charitable contributions."
- (c) There must be compliance with the Revenue Act

of 1987 provision of any general order by U.S. temples.

4. Compliance with Applicable Laws:

It is the responsibility of the temple Potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

#### Financial Records:

- (a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles and affiliated and appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.
- (b) The temple must retain such detailed financial records for a period of seven (7) years.
- (c) There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any General Order.
- 6. Notification to Nobility:

A copy of the Fundraising Activities provisions of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

#### 7. Prior Permission:

Every Noble (in his capacity as a Shriner), club, unit, temple, organization of Nobles or affiliated or appendant corporations is prohibited from entering into any telemarketing agreement or contract to raise money for the benefit of Shriners Hospitals for Children without first obtaining written permission from the chairmen of the boards of directors and trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P. O. Box 31356, Tampa, Florida 33631-3356.

#### 8. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of Shriners International.

9. Shriners International Education Foundation: Notwithstanding the previous provisions of FUND-RAISING ACTIVITIES stated above, Nobles may contribute, encourage other Nobles to contribute and engage in charitable fundraising activities directly to Nobles and their families for the benefit of the Shriners International Education Foundation.

Lady Tara is hoping to raise most of the money by selling raffle tickets for a trip to Montreal, including air fare, hotel, spending money, a tour of Shriners Hospital for Children-Canada, as well as tickets to a Montreal Canadiens NHL hockey game.
